## Guarantee Conditions

### 1 INTERPRETATION

1.1 In the deed and these conditions the words listed below have the meanings shown beside them:

"student"	the person named the student in the contract
"debt"	all money which the student owes interstudy under the contract at any time
"deed"	the particular deed of guarantee and indemnity to which these conditions apply
"contract"	the study abroad contract referred to in this deed and any other agreement (whenever it is made) by which the student comes under obligations to us which you agree (by signing the agreement or otherwise) should be covered by the deed
"interstudy"	interstudy (Bath) Ltd of The Countess of Huntingdon 's Chapel, The Vineyards, Paragon Bath, BA1 5NA, England
"guarantor"	the person(s) named as guarantor in the deed and their successors

1.2 If there is more than one guarantor the terms of the deed and these conditions apply to all those named as guarantor and to each of them on their own.

1.3 The liabilities covered by the deed include all liabilities of the student to interstudy in connection with the contract whether or not a particular liability has yet arisen or become enforceable or depends upon the occurrence of another event

### 2 GUARANTEE AND INDEMNITY

2.1 The guarantor promises to pay interstudy on demand any part of the debt which the student owes to interstudy at any time and which is due from the student at the date of demand on the student. If the guarantor does not pay interstudy at the date of their demand on the guarantor then the guarantor must pay interstudy such amount demanded together with interest calculated from the date of interstudy 's demand on the guarantor until the date of actual payment at the rate applicable to court judgements at the time when the demand is made.

2.2 The guarantor also and separately promises to pay to interstudy on demand in full all losses costs and expenses it may suffer or incur as a result of the student 's failure to perform any obligation or meet any liability under the contract

### 3 PROTECTION

3.1 The guarantor agrees that the deed is a continuing guarantee of the debt which the student owes interstudy at any time

3.2 The deed will remain in full force until the debt has been paid

3.3 interstudy may enforce its rights against the guarantor under the deed and these conditions before it takes steps against or obtains any judgement against the student if it is acting reasonably

3.4 The guarantor agrees that until the student has paid interstudy all of the debt he/she will not:

- demand or accept from the student or anyone else who has guaranteed the student 's obligations under the contract any money which he/she is owed by the student as a result of performing obligations under the contract and these conditions
- enforce any right or remedy the guarantor may have against the student or anyone else as a result of performing those obligations
- compete with interstudy in the bankruptcy of the student or any other guarantor

### 4 APPLICATION OF MONEY

The guarantor agrees that interstudy has the right to decide how to apply any money received by them from him/her under the deed

### 5 DEMANDS AND NOTIFICATIONS BINDING

The guarantor agrees to be bound by written statement from interstudy of the amount due and payable in connection with any provision of the deed and these conditions

### 6 EXPENSES

The guarantor must pay interstudy all expenses which interstudy reasonably incurs in connection with the deed or the contract
